# **OBJECTIVE:**

Review and discuss key revenue and cost drivers related to the draft Operating & Maintenance and Capital Improvement Budgets for 2024.

# **BACKGROUND AND ANALYSIS:**

Following the Strategic Planning Session on May 23, 2023, staff has updated the Financial Model and prepared the proposed 2024 Operating & Maintenance and Capital Improvement Budgets. At the August 21, 2023 Special Board Meeting, staff will provide a presentation concerning projected Operating & Maintenance and Capital expenses for the coming year. The presentation will highlight key programs and projects planned for 2024 and rate/funding options.
