OBJECTIVE:

Review and discuss key revenue and cost drivers related to the draft Operating & Maintenance and Capital Improvement Budgets for 2022.

BACKGROUND AND ANALYSIS:

Following the Strategic Planning Session on May 26, 2021, staff has updated the Financial Model and prepared the proposed 2022 Operating & Maintenance and Capital Improvement Budgets. At the September 9, 2021 Special Board Meeting, staff will provide a presentation concerning projected Operating & Maintenance and Capital expenses for the coming year. The presentation will highlight key programs and projects planned for 2022 and rate/funding options.

Staff will seek direction from the Board regarding funding options for consideration. Should the Board wish to further consider more than one option, a refined set of funding options will be presented to the Board at the September 15, 2021 Board Meeting.
