

SUBJECT : DISCUSSION AND POSSIBLE ACTION TO ADOPT RESOLUTION 12-2023 AMENDING RESOLUTION 10-2023 APPROVING AND CONFIRMING THE REPORT OF DELINQUENT UTILITIES CHARGES AND REQUESTING SACRAMENTO COUNTY TO COLLECT SUCH CHARGES ON THE TAX ROLL

OBJECTIVE:

Consider adoption of Resolution 12-2023 amending Resolution 10-2023 (Sacramento County) approving and confirming the Report of Delinquent Utilities Charges and requesting Sacramento County to place such charges on the tax roll.

BACKGROUND AND ANALYSIS: -

At the June 17, 2023 Regular Board Meeting the Citrus Heights Water District (CHWD or District) Board of Directors adopted Resolutions 10-2023 (Sacramento County) and 11-2023 (Placer County) approving and confirming the Report of Delinquent Utilities Charges and requesting the respective county to place such charges on the respective tax roll.

The District’s process of referring delinquent utility bills to the County to be placed on the property tax roll through the Direct Levy process was implemented in 2021 to replace the former service termination procedure.

Staff conducted a second review of all outstanding accounts and identified 60 additional accounts in Sacramento County that have been delinquent for more than 90 days and have a balance greater than \$50 as of June 1, 2023. Delinquent charges for Sacramento County accounts amount to \$199,166.84. The County of Sacramento accepts submission of direct levies once per year and sets the deadline in the first week of August, for agencies to submit listings for the tax year. The tax year for this group of levies is 2023/2024 (July 1, 2023 – June 30, 2024). Staff are proposing to amend Resolution 10-2023 to include the additional accounts in Exhibit A of the Resolution.

Although the deadline to submit accounts is in early August, respectively, the District may remove an account from the Direct Levy roll up until the first week of September, 2023. This will allow the District to make a final attempt to contact the customer and obtain either an amortization agreement or payment, prior to the deadline for removal from the tax roll.
