OBJECTIVE:

Consider action to designate a voting delegate for the Citrus Heights Water District (CHWD or District) during the 2023 ACWA Board Officers' Election

BACKGROUND AND ANALYSIS:

CHWD is a voting member of the Association of California Water Agencies (ACWA). Historically, ACWA has conducted the annual nomination and election of its officers at a General Session Membership Meeting during its Fall Conference (Conference). Prior to the Fall Conference each year, the District's Board of Directors has had an opportunity to designate a voting delegate. ACWA's election process was recently changed; and going forward, members of ACWA will elect the President and Vice President by voting electronically before the annual meeting at Fall Conference.

Under ACWA's new election process, each member agency must designate one voting representative by June 16, 2023. Only designated voters will receive the electronic ballot; and if CHWD does not designate a voting representative by the June 16 deadline, the General Manager will be the authorized voter by default.

The authorized voter will receive an electronic ballot on July 17, 2023, that will include the names of all qualified candidates. There will also be a space to write in the name of an eligible candidate. All ballots must be submitted electronically, between July 17-Sept. 15, 2023, except for those who opt out of electronic voting in lieu of first-class mail. The deadline for voting is 5 p.m. on Sept. 15, 2023. Mailed ballots must be postmarked by Sept. 15th and received by Sept. 20th to be counted. There will be no voting at the Fall Conference.

Board President, Ray Riehle is the current ACWA Representative for the District, and Vice President, David Wheaton is the alternate. Therefore, staff recommends that the Board designate either the District Board President, Board Vice President, or General Manager as the District's Delegate; and authorize the General Manager, or his designee, to complete the Authorized Voting Representative Form and submit it to ACWA by the requested deadline.

RECOMMENDATION:

- 1. Designate the District's voting delegate for ACWA's 2023 Board Officers' Election
- 2. Authorize the General Manager or designee to complete and submit the Authorized Voting Representative Form to ACWA.
