Mandatory Water Regulations Continue

here continues to be a lot of buzz in the news about California's ongoing drought. The State's water supply situation is dismal, with limited surface water supplies and no Sierra snowpack. As this drought remains, so must our State-mandated reduction regulations.

In June, we notified our customers about a State-mandated reduction of 32% from the 2013 gallons per capita (per person) per day (GPCD). These reductions are outside of our control as your local water supplier. Our 2013 usage was 207 GPCD or 5.65 units of water per person per month. To meet our 32% reduction goal, CHWD customers need to reduce water use down to 141 GPCD. While this may seem challenging, CHWD customers have an incredible ability to meet water conservation goals.

We understand that it can be difficult to continue to find ways to reduce water usage. Please keep in mind that reducing outdoor watering is the best way to cut back. To help meet these conservation goals, outdoor irrigation is limited to two pre-scheduled days per week (see

the Watering Schedule table below). Other regulations for water use reductions are outlined in the Stage 4- Water Crisis Regulations on Page 2 of this newsletter.

We are also doing our part to conserve the water supply and ensure that water is not wasted. CHWD crews are committed to a short response time to fix leaks in the system faster. We are as committed as you are to protecting our region's most valuable resource.


We are asking for your help by reporting residential or commercial waste of water. CHWD will investigate claims of wasted water. The District intends to work cooperatively with all customers to comply with mandated regulations. Drought Rates

n response to the State's water reduction requirements, CHWD adopted a temporaty drought rate increase based on water use, which went into effect July 15, 2015. This rate is not intended to be permanent; however, it will remain in effect until further notice.

A typical residential customer bill consists of approximately 65% service charges. This portion of the bill remains the same. The other 35% of the bill, which consists of charges for actual water use, was increased by 25%. This increased the cost of actual water use from \$0.7663 to \$0.9579 per 748 gallons, or 100 cubic feet of water (1 billing unit). Please refer to the diagram below:



Watering Schedule

Under the Stage 4 Restrictions, outdoor watering is limited to two days per week. Days of the week are based upon the last digit of your address number. For example 123 Main Street is "odd" and 144 Main Street is "even"

Stage 4 – Water Crisis Regulations

- 1. Under State Water Resources Control Board (SWRCB) mandate, the District must reduce overall water usage by 32% from 2013 use.
- 2. Water shall be used for beneficial purposes only; all unnecessary uses of water are prohibited.
- 3. Irrigation for pop-up sprinklers and non-drip irrigation systems shall be limited to two days per week. The days of the week when outdoor water is permitted shall be set based on the last digit of the street address. Odd addresses, streetscapes, and medians shall limit watering to Tuesdays and Saturdays; even addresses shall limit watering to Wednesdays and Sundays. No irrigation is permitted on Mondays, Thursdays and Fridays. Irrigation should be limited to the minimal amount of water necessary to keep plants and trees alive. Application of potable water to outdoor landscapes during and within 48 hours after measurable rainfall is prohibited. Please visit www. chwd.org after each rainfall to determine if watering is permissible.
- 4. Water shall be confined to the customer's property and shall not be allowed to run-off to adjoining properties, non-irrigated areas, private and public walkways, roadways, driveways, sidewalks, parking lots, structures or to the roadside ditch or gutter. Care shall be taken not to water past the point of saturation.
- Free-flowing hoses for all uses are prohibited. Automatic shut-off devices shall be attached on any hose or filling apparatus in use.
 Customers are encouraged to wash automobiles or equipment at commercial establishments that use recycled or reclaimed water.
- Leaking customer pipes or faulty sprinklers shall be repaired within 24 hours or less if warranted by the severity of the problem. Noncompliance may result in water service being disconnected/shut off until the leak is repaired and assessment of a disconnect/reconnect service charge.
- 7. All pools and spas shall be equipped with a recirculation pump and shall be constructed to be leak-proof. Pool draining and refilling is prohibited unless specifically authorized by the District for health, maintenance, or structural purposes subject to written documentation by a pool maintenance professional.
- 8. Use of potable water to fill or refill artificial lakes or ponds, ornamental ponds, and fountains is discouraged.
- 9. Washing streets, parking lots, driveways, sidewalks, or buildings is prohibited except as necessary for health or sanitary purposes.
- Customers are encouraged to take advantage of the District's water conservation programs and rebates. For more information please visit www.chwd.org/conservation.
- 11. Irrigation with potable water of ornamental turf on public street medians is prohibited.
- 12. Commercial, industrial and institutional (CII) customers, which include public schools, public parks, public and private cemeteries and private golf courses, can choose to submit an alternative water use reduction plan to the District for consideration.
- 13. Eating and drinking establishments, including but not limited to restaurants, hotels, cafes, cafeterias, bars, or other public places where food or drink is served and/or purchased shall serve water only upon request.
- 14. Flushing of sewers or fire hydrants is prohibited except in cases of emergency, essential District operations or unless specifically authorized by the District.
- 15. Water for flow-testing is prohibited. Water for construction purposes from fire hydrants and blow-offs will be metered and monitored. Use of reclaimed water for construction purposes is encouraged.

- 16. No new commitments will be made to provide service for new water service connections unless the Department of Water Resources Model Water Efficient Landscape Ordinance, found at http://www.water.ca.gov/wateruseefficiency/docs/MWEL009-10-09.pdf is followed and the plans have been approved by the county or city building department which has jurisdiction over the property location. Any authorized landscape for new connections is subject to all restrictions set forth in these Stage 4 Water Crisis Regulations.
- Irrigation of new turf or landscaping outside of newly constructed homes is prohibited unless water is delivered by drip or micro spray systems.
- 18. Customers are encouraged to reduce landscape and pasture irrigation by a minimum of 32%. Customers with "smart" irrigation timers or controllers are asked to set their controllers to achieve a minimum of 32% conservation.
- 19. Customers are encouraged to reduce indoor water use by a minimum of 32%. Contact the District for tips and techniques to reduce indoor water use.
- 20. Stage 4 Water Crisis "Water Shortage Charge" pricing went into effect on July 15, 2015, and will remain in effect until further notice.

Save Water and Money with CHWD's Rebates

In this time of drought, having efficient appliances is critical to conservation. If you have not replaced your old toilet and/or washing machine with a new water efficient one, we highly recommend it! CHWD offers rebates for both of these items. Toilet rebates could earn you a rebate of up to \$75. Through a partnership with SMUD, CHWD also offer rebates on high-efficiency clothes washing machines. Are You Irrigating Efficiently?

During this time of incredibly stringent water requirements, CHWD customers are limited to two days of irrigation per week. We highly encourage you to take advantage of our FREE irrigation efficiency reviews to make sure that you aren't wasting a drop! Please call us at (916) 725-6873 to have a trained technician visit your home and evaluate your watering system. He or she will leave you with a written report with tips to improve your irrigation efficiency and a custom watering schedule based on your landscape's needs. It is highly recommended that you consider replacing your lawn, or other water-thirsty landscape with more drought efficient options. Your local nursery can help with ideas!

Summer 2015 Construction Update

Here at CHWD we are wisely investing your rates back into the water system. Our continued goal is to provide quality and reliable service to you. Particularly during this time of drought, we want to make sure that the infrastructure is up to date and that no additional water is being wasted as a result of broken, aged pipes. Besides pipeline replacement, CHWD is also continuing work on a sixth groundwater well. This well, the Skycrest Well, is underway and is expected to be operational in September.

Additionally, CHWD is still operating out of its temporary office location at 7011 Sylvan Rd. in Citrus Heights. The main office at 6230 Sylvan Road is undergoing a remodel and addition to modernize the customer service lobby, meeting room, bathrooms and support staff work areas. The remodeled office is expected to reopen in September 2015.
